However, HS2 turned up at the wood today to start work. Another Cllr rang HS2 and asked if they had asked for this to happen. HS2 stated they were unaware this was happening. Cllr Adam said SDC has advised him the two signs for Ufton Fields on the corner are necessary. The other sign for Ufton Fields is directional so it will not be removed.
